The major challenge for the future of pharmaceutical companies is to support their R&D in order to convince the market of the potential of their molecule portfolio and direct their efforts towards an economic sector with high added value and little delocalisation: biotechnologies.

The cosmetics sector, which is very dynamic, is continuing to grow. The strategy of stakeholders is different depending on the precise business line, with a trend to outsourcing production in order to have industrial sites as close as possible to raw materials.

Ecological issues are playing a major role, with regulations obliging manufacturers to roll out environmentally friendly processes. Multinationals are investing in organic companies and developing niche products for specific ranges featuring "green" labels.

The multiplication of standards and norms such as Pharmacopoeia, GMP, ISO 22716 and so on, along with the tightening of the domain requirements and related inspections by dedicated organisms (FDA, ANSM, EMEA...) involves being fully conversant with all measurements taken: relevance, traceability, uncertainty, etc.

This level of requirements has revealed calibration needs which call for recourse to specialists in measurement process management. 
